## SCHOLARSHIP CATEGORIES and REQUIREMENTS

### Categories

- 1) C. Richard Skogley Memorial Scholarship to a University of Rhode Island turf student;
- 2) an employee of a RIGCSA superintendent, having been employed by that superintendent for at least two seasons, who is attending an accredited 4- or 2-year turf school;
- 3) a child or grandchild of a RIGCSA member attending an accredited 4- or 2-year turf school; or
- 4) a child or grandchild of a RIGCSA member attending an accredited 4- or 2-year college or university.

### **Requirements**

- 1) A sponsor must be an active member of the RIGCSA for a minimum of three years;
  - a. "active member" is a subjective term not defined by dues paying
- 2) A member may sponsor only one applicant per year.
  - a. sponsor must be child's parent, grandparent or current employer
  - b. sponsor must have all accounts within association paid in full
- 3) A sponsor must write a letter of recommendation on behalf of the applicant.
- 4) **Applicant must provide a verification of enrollment from the University for this year such as verification from the Bursar's office.**
- 5) Freshman (First year) students are not eligible for a scholarship.
- 6) Graduate students are not eligible for a scholarship.
- 7) Applicants are not eligible for a scholarship in consecutive years.
- 8) Applicants must be enrolled on a full-time basis with a minimum curriculum of 12 credits per semester.
- 9) Applicants will be required to fill out a scholarship application form provided by the S&R Committee.
- 10) All above requirements must be met for applicant to be considered.
- 11) Maximum 2 scholarships per student
